## Abstract

Finance Department—Introduction of Centralised System for the Payment of Electricity/Water Charges of Government Departments—Amendments—Issued

G. O. (P) No. 101/13/Fin. Dated, Thiruvananthapuram, 23rd February, 2013.

Read:-1. G.O. (P) No. 706/12/Fin. dated 26-12-2012.

 D. O. No. Fin. 1/Credit/Centralised System/2012-13 dated 18-1-2013 of the Chairman, KSEB.

As per the G. O. read above, Government have introduced a Centralized system of payment of electricity/water charges with effect from 1-1-2013 under which the Heads of Departments shall make all payments of electricity/water charges in respect of all his subordinate offices directly to KSEB/KWA from 1-1-2013.

The Chairman, KSEB, vide his D. O. letter read above, has requested to withhold the implementation of the order till 1-4-2013 since various measures have to be completed before the switch-over to the new system, such as the process of mapping the Government Department against which each office has to be attached etc. It is also informed that at present, the payment of electricity charges of serveral educational institutions/hospitals are not made from Government funds but are borne by bodies like Parent Teacher Associations' of the Schools/Hospital Development Committees etc.

After having examined the matter in detail, Government are pleased to order that the new system of payament of Electricity/Water Charges envisaged by the Government Order read above will be effective only with effect from 1-4-2013. Further, Government Institutions which makes payment towards Electricity/Water Charges from sources other than Government Fund such as PTA Fund/Hospital Development Committees etc. (i.e. Schools, Colleges, Public Health Centres and Hospitals under the Directorate of Public Instructions, Directorate of Technical Education, Directorate of Collegiate Eudcation, Directorate of Vocational Hilger Secondary Education, Directorate of Higher Secondary Education, Directorate of Health Services and Directorate of Medical Education) are exempted from the new centralized system of payment of Electricity/Water Charges. However the system will apply to Government offices in the above Departments also.

The G. O. read above stands modified to this extent.
