ORDER

As per the Government Order read above, wages of persons engaged on, daily wage and contract basis were enhanced with effect from 01.04.2016. In the wake of the above order, proposals from different Departments/Offices requesting to enhance the wages of various categories of staff who are not included in the Government Order cited above have been received. Government after having examined the proposals in detail are pleased to include the following categories of staff under the purview of the Government Order dated 26/02/2016, as per the Annexure appended. Government also order that all the guidelines stipulated in G.O. (P) No. 28/16/Fin dated 26.02.2016 remain applicable without any change. The categorization in the Annexure will apply only for full time work. This will not apply to those engaged casually for doing part -time work, like sweeping.

This Government Order has prospective effect only.


