ORDER

In the current year's budget 2016-17 there is a provision of Rs.180 lakhs under the Head of account “2202-03-105-99-Faculty Development 34- Other Charges (Plan)”. This Scheme is intended to provide in-service training programmes such as Seminars, Refresher Courses, Exhibitions etc. to the teaching faculty. The Principals of Government Colleges have submitted proposals for financial assistance under this scheme. After examining the proposals funds are sanctioned for 48 Government Colleges for an amount of Rs.180 lakhs as shown against the name of each college. The expenditure under this scheme should be limited to the allotted amount.


