**ORDER**

The Promotion of the Non Teaching Staff of St. Joseph's College Irinjalakuda is approved provisionally as details in the statement annexed. Copy of this order and statement thereto duly attested by the Principal should be pasted in the Service Book of the incumbent concerned.

The Deputy Director of Collegiate Education concerned should verify the qualification required for the Promotion vide Col.3 of the statement in respect of the persons now promoted before admitting the first salary in the promoted post.

In the case of Promotions, whose date of birth and general qualifications have not been verified and attested in the Service Book earlier by Deputy Director of Collegiate Education, such verification and attestation should be made at this stage before admitting salary.

In the case of persons who have been provisionally promoted subject to conditions the Principal should enter the details of promotion with the conditions thereto in the Service Book of the incumbent quoting this office order. The Deputy Director of Collegiate Education should verify whether this has been done before admitting salary in the promoted post. The Deputy Director of Collegiate Education should also ensure that the number of persons for which salary is admitted by him/her does not exceed the sanctioned strength.

This approval is subjected to the conditions stipulated in the concerned University Statutes and Government Orders


