### ORDER

In the current year's budget (2018-19)there is a provision of Rs 900 lakh under the head of account 2202-03-103-75-01-College Infrastructure Upgradation Programme(Plan) .The purposes of the scheme are 1) Construction of building for Colleges and Hostels 2) Minor construction works for general improvement in facilities 3)Maintenance of playgrounds and improvement of sports facilities 4)Conservation of heritage value of Colleges and Hostels 5) Purchase of sports goods and 6)Students amenities.

The Principals and the Wardens have submitted proposals for financial assistance under the Scheme.After examinining the proposals a total amount of **Rs 8,74,598/-**(Rupees Eight Lakh Seventy Four Thousand Five Hundred and Ninety Eight Only)is allotted to the following Govt.Colleges and Hostels for the various demands as per the proposals submitted by the Principals and the Wardens under the head of account 2202-03-103-75-01-CIUP as shown below


