With regard to the above subject I am to inform you that it has come to the notice of the Honorable President of India that some of the Universities in Kerala, all Government Colleges and other educational institutions are continuing to invite Quotations/Tenders/Negotiations for the purchase of books, publications and periodicals etc. In this regard it is noted that there is an unhealthy competition among book sellers/publishers to increase the prices of books so as to offer hike in commission to be paid to the buyers. As a result of this procedure, the institutions are not getting appropriate books on time. The faculties/scientists are forced to accept the books which they are getting. They are not getting a chance to go through the books before selection. This system of purchasing books through Quotation/Tender/Negotiation helps only to deteriorate the quality of

education.


In the circumstances you are requested to take necessary action to refrain from the practice of inviting Quotation/Tender/Negotiation for the purchase of books, periodicals etc.
