ORDER

In the current year's budget (2018-19)there is a provision of Rs 900 lakh under the head of account 2202-03-103-75-01-College Infrastructure Upgradation Programme(Plan) .The purposes of the scheme are 1) Construction of building for Colleges and Hostels 2) Minor construction works for general improvement in facilities 3)Maintenance of playgrounds and improvement of sports facilities 4)Conservation of heritage value of Colleges and Hostels 5) Purchase of sports goods and 6)Students amenities.

The Director of Collegiate Education had submitted following proposals to the Government for obtaining administrative sanction by meeting the expenditure from the Head of account 2202-03-103-75-01-CIUP
