2. The Minutes of the 34<sup>th</sup> meeting of the Equivalence Committee, held on 26-12-2013.

ORDER

1.As per the paper read first above, the Academic Council of this University, at its meeting held on 31-12-02 resolved to constitute the Equivalence Committee to deal with the cases of recognition of Degrees/Diplomas/Courses of other Universities/ Boards/Institutions.

2.The Equivalence Committee at its 34<sup>th</sup> meeting, held on 26-12-2013, vide paper read second above, considered the question of recognition of Degrees of other Universities and resolved to recognize the following Degrees awarded by the specified Universities as detailed below.

3	University of Mysore , Karnataka	M.Sc Polymer Science (Regular)	M.Sc Chemistry	Recognized as equivalent to M.Sc Chemistry Degree of Kannur University for the purposes of Higher Studies and Employment,

3. The 34<sup>th</sup> meeting of Equivalence Committee also resolved to implement the following decisions.

- i) Decided not to recognize M.Com (Distance Education) Degree of Mangalore University, Karnataka as equivalent to the M.Com Degree of Kannur University for any purpose.
- ii) Decided not to recognize M.Com (Distance Education) Degree of Bharathiar University, Tamilnadu as equivalent to the M.Com Degree of Kannur University for any purpose.
- iii) Decided not to recognize B.C.A (Distance Education) Degree of Makhanlal Chaturvedi National University of Journalism and Communication, Bhopal, Madhyapradesh, as equivalent to the B.C.A Degree of Kannur University for any purpose.
- iv) Decided to constitute a committee for preparing the norms for the recognition/equivalence of degrees offered by other Universities with the following members.
  - i. Two Syndicate Members from the Equivalence Committee.
  - ii. One Expert each from Language, Arts, Science, Commerce & Management and Engineering discipline.
- v) Decided to levy a fine of 10,000/- per student from those institutions who fails to admit students without ensuring their eligibility for higher Studies in the subject concerned and to summarily cancel the admissions in respect of the students concerned.

5. After considering the recommendations of the Equivalence Committee, the Vice Chancellor in exercise of the powers of the Academic Council has accorded sanction to recognize the said Degrees awarded by the said Universities and Institutions detailed above and also accorded sanction for implementing the decision of Equivalence Committee detailed in para 3 above, subject to reporting to the Academic Council.
