ORDER

In the Annual Plan of 2017-18 an amount of Rs.250 Lakh (Rupees Two Hundred and Fifty Lakhs Only) is provided under the Head of Account - 2202-03-103-68-(01) of College Quality Improvement Programme (CQIP) Scheme.

The Departmental Working Group for Higher Education Department held on 03/01/2018 has considered the proposal forwarded by the Director of Collegiate Education for Construction of 2nd floor of the building of Govt. Arts and Science College Nadapuram for an amount of Rs.165 Lakhs and approval was accorded for an amount of Rs. 165Lakhs (Rupees One Hundred and Sixty Five Lakhs only). As per the G.O cited above Government has accorded Administrative Sanction for the Construction of 2nd floor of the building of Govt. Arts and Science College Nadapuram for an amount of Rs. 165Lakhs (Rupees One Hundred and Sixty Five Lakhs only) under the scheme of College Quality Improvement Programme (CQIP-Head of account-2202-03-103-68-(01) subject to certain general conditions.

General Conditions

1. The release of the funds will be need based when actual expenditure falls due.
2. The total expenditure will be limited to the Current Year's Budget Provision.
3. For the construction work, time of completion should be specified.
4. If accredited agency is executing the works, time of completion along with "Penalty Clause" should be included in MOU/Agreement.
5. For Civil works, PRICE software should be adopted.

Therefore sanction is hereby accorded for the allotment of **Rs. 165 Lakhs (Rupees One Hundred and Sixty Five Lakhs only)** to the Principal of of Govt. Arts and Science College Nadapuram for the Construction of 2nd floor of the building. The Principal should observe all the procedural formalities and rele vant rules while utilizing the fund. Principal must do a regular monitoring of the work progress and has to report to this office periodically.

Administrative Sanction was issued for the entire building under MLA LAC-ADS as per the G.O (Rt) No.570/0 2016 H.L. an Dated 25.02.2016 for Rs.500Lakhs. However as piling had to be done following soil investigation, only ground floor could be completed under the scheme and hence a revised Administrative sanction is required for the completion of building in 3 Floors . Government has also directed PWD to entrust the work to Uralungal Labour Contract Society and also for the clear demarcation of funds granted to the project from either of the two schemes.

The expenditure on this account will be met from the Head of Account 2202-03-103-68-(01) of College Quality Improvement Programme (CQIP) Scheme in the current year's budget.
