Higher Education Department –Payment of Sixth UGC Pay Revision Arrears-Release of Second Installment -Sanctioned-Orders issued.

ORDER

Government, as per the order read as first paper above have issued orders implementing Sixth UGC Pay Revision and Scheme for teachers in Universities, Affiliated Colleges, teachers in Law Colleges, Engineering Colleges, Kerala Agricultural University and teachers in Physical Education and qualified Librarians. Subsequently, Government, as per the order read as second paper above have decided to disburse the arrears of the Sixth UGC Pay Revision in four installments and also accorded sanction for the release of an amount of Rupees 314,08,68,936/-(Rupees Three hundred and fourteen Crores eight lakhs sixty eight thousand nine hundred and thirty six only) being the first installment of arrears for the period from 01.01.2006 to 30.06.2007.

Government have now decided to disburse the second installment of Sixth UGC Pay Revision arrears for the period from 01.07.2007 to 30.06.2008. Government are, therefore, pleased to accord sanction for the release of an amount of Rs.232,47,57,984 (Rupees Two hundred and thirty two Crores forty seven lakhs fifty seven thousand nine hundred and eighty four only), being the second installment of arrears for the period from 01.07.2007 to 30.06.2008 and order that for those teachers in service the arrears will be credited to their Provident Fund Account and it will be paid in cash to the retired teachers.

The lock-in-period of the arrears credited in the Provident Fund account will be five years from the release of second installment of arrears, i.e 31.5.2020 beyond which time the amount may be withdrawn in the case of those in service.

The income tax payable on the arrears shall be adjusted from the arrear salary bills.
