ORDER

In the current year's budget there is a provision of Rs 65 lakh under the Head of Account "2202-03-103-85-Introduction of Autonomy and Related Developmental Activities in Selected Well Established Colleges(Matching Grant)".Government have constituted college development committee(CDC) in colleges with District Collector as chairman to look after the developmental activities of colleges by collecting funds from alumini associations,general public etc. An equal share of the amount collected by the CDC will be sanctioned to colleges as matching grant under this scheme.The amount collected by the colleges as CDC funds and this matching grant could be utilised for the overall development of the colleges as per the decision of the committee.

Out of this amount Rs 64,86,825/- (Rupees Sixty Four lakh Eighty Six Thousand Eight Hundred and Twenty Five only) had already been sanctioned to 27 Govt. Colleges as Matching Grant for the financial year 2017-18 as per the reference 1st cited. As per the references 2nd and 3rd cited above S.A.R.B.T.M Govt. College Koyilandi and Govt College Ambalappuzha have surrendered Rs 1,16,000/- and Rs 51,625/- respectively.

The Principal Govt.College Thrippunithura has submitted proposal and requested financial assistance under this scheme .After examining the proposal **Rs 1,79,000/- (Rupees One lakh Seventy Nine Thousand Only)** is sanctioned to The Principal Govt .College Thripunithura as Matching Grant for the financial year 2017-18 as shown below
