**ORDER**

In the Annual Plan of 2018-19 an amount of Rs.120 Lakh (Rupees One Hundred and Twenty Lakhs Only) is provided under the Head of Account- 2204-00-101-99- Physical Education Colleges.

As per the reference 1<sup>st</sup> cited Departmental Working Group for Higher Education Department held on 31.05.2018 has considered the proposal for a total amount of Rs. 73,43,000/- Lakhs (Rupees Seventy Three Lakh Forty Three Thousand Only) forwarded by the Director of Collegiate Education Accordingly Government have accorded Administrative Sanction for a total amount of Rs. 73,43,000/- Lakhs (Rupees Seventy Three Lakh Forty Three Thousand Only) for the below mentioned purposes of Govt. College of Physical Education Kozhikode.

Therefore sanction is hereby accorded for the allotment of a total amount of Rs. 73,43,000/- Lakhs (Rupees Seventy Three Lakh Forty Three Thousand Only) to the Principal of Govt. College of Physical Education Kozhikode subject to certain general conditions mentioned.

**General Conditions**

1. The release of the funds will be need based when actual expenditure falls due.
2. The total expenditure will be limited to the Current Year's Budget Provision.
3. Stores Purchase Rules, other Government Orders and Circulars should be strictly followed.
4. For the construction work, time of completion should be specified if accredited agency is executing the works, time of completion along with "Penalty Clause" should be included in MOU/Agreement.

The Principal should also ensure that the allotted amount is released for the specific purposes. The Principals concerned should observe all the procedural formalities and relevant rules while utilizing the fund. Principal must do a regular monitoring of the work progress and has to report to this office periodically. The utilization certificate should also be furnished in due course.

The expenditure on this account will be met from the Head of Account - 2204-00-101-99- Physical Education Colleges Scheme in the current year's budget (2018-19).
