I am to invite your attention to the reference cited and to inform that the provisions in para 6.1.9, 6.1.10 & 6.1.11 of the Government Order first cited allow re-designation of all Selection Grade Lecturers/Readers in service as Associate Professor on completion of three years service unconditionally. They are not supposed to satisfy any qualifying conditions for such re-designation and no separate order from Government is necessary for granting this benefit. Further, Ministry of Human Resource Development, Government of India, as per reference (2) cited(copy enclosed) has also conveyed the decision for such re-designation to the Selection Grade Lecturers/Readers who are appointed or promoted on or after 1/1/2006 till 30/6/2010. Hence, it is informed that all Selection Grade Lecturers/Readers as on 30/06/2010, may be re-designated as Associate Professors as and when they complete three years as Selection Grade Lecturers/Readers, without any separate placement/re-designation orders and their pay fixation may be done accordingly.


