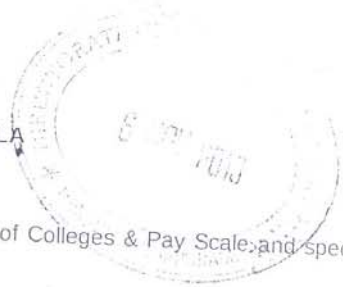

ORDER

In the Government order read above, Government have issued orders implementing the Sixth UGC Scheme & Pay revision to the teachers and equivalent cadres in the Universities and affiliated colleges in the State. Under this scheme, the UGC has recommended two types of colleges viz; UG Colleges & PG Colleges and special allowances have also been prescribed for principals of these colleges. Accordingly, the Director of Collegiate Education in the letter read above has requested Government to issue necessary orders prescribing guidelines for the categorization of the colleges as envisaged by the UGC.

Government have examined the proposal and are pleased to issue the following orders in this regard:

1. A College with at least One PG Course excluding self financing/conditional courses shall be identified as PG College and a college where UG courses alone are offered shall be identified as UG college.
2. The Pay scale of Principals & the fixation of Pay shall be done in accordance with the instructions under clause 7.3.1 & 7.3.2 and in the Appendix to the Government order dated 27.3.2010.
3. The Principal of a UG College shall be eligible for a special allowance of ₹2000/- per month and the Principal of a PG College shall be eligible for a special allowance of ₹3000/- per month. Considering the higher level of administrative responsibility, the Deputy Director of Collegiate Education & Additional Director of Collegiate Education shall also be eligible for monthly special allowance of ₹2000/- and ₹3000/- respectively. The Director of Collegiate Education will take necessary action to implement the above instructions and to identify the UG & PG colleges forthwith.
