## **ORDER**

A Selection Committee for furnishing a list of teachers for placement to the post of Professor had been constituted by Director of Collegiate Education. Based on the report of the committee a list was published vide circular no: UGCCELL2/22139/2021 dated 10.02.2023. After publishing the list several complaints regarding the list were received. Consequently, the Chairperson of the Selection Committee decided to conduct an initial verification of all the proposals for Professor Placement through a committee and found several anomalies and errors in the published list. On the basis of initial verification it was decided to withdraw the list of professor placement published vide circular no. UGCCell2/22139/2021 dated 07.03.2023 Later a first level scrutiny was conducted by a committee constituted by the Chairperson of the Selection committee and the same has been completed by 20.03.2023. On the basis of decision of selection committee and verification of first level of scrutiny committee, following 35 eligible applicants are awarded professor placements (Academic level 14) in the entry pay of ₹ 1,44,200/- as per the 2018 U.G.C guidelines with effect from the date mentioned against their name.
