ORDER

As per the Government Orders read as 1st and 2nd above, Government have implemented UGC 7th scheme in the state. As per the order read as (4) above Government have accorded sanction for granting Professor Placement of teachers in universities and colleges in the state coming under 7th UGC scheme from 18.07.2018 on wards, in accordance with the provisions in the UGC Regulation 2018.

As per the circular read as 7 above, the principals of Govt. Colleges have submitted the proposals for placement as Professor (Academic Level 14) to this office. According to the provisions in UGC 2018 Regulation, the claim for CAS - Professor (Academic Level 14) have to be approved by the Selection Committee constituted by the Director of Collegiate Education.

As per the order of Director of Collegiate Education read as (9) above a Selection Committee had been constituted for furnishing a list of Physical Education teachers for placement to the post of Professor (Academic Level 14). Based on the order , the Subject Experts were verified the proposals of teachers in detailed. After the final consultation of Subject Experts , candidates were interviewed on 18.01.2023 by the Selection Committee.

On the basis of the decision of Selection Committee and the valuable concurrence of Subject Experts, 4 eligible applicants were awarded Professor placement (Academic Level 14) in the entry pay of RS. 1,44,200 /- as given in Annexure to this order.

The placement granted as per this Order is subject to the following conditions.

1. This Order is subject to verification of the Accountant General, Kerala concerned for issuing pay slips.

- 2. If any amount drawn by the incumbent by this Order is found to be in excess due to mistake or any other reason, noticed later, he/she would be liable to refund the amount so received in lump unconditionally.
- 3. The incumbent should submit his/her option and declaration for the fixation of pay within three months of this Order to Directorate of Collegiate Education there after to the Accountant General, Kerala.
