ORDER

As per the Government Orders read as 1st and 2nd above, Government has implemented UGC 7th scheme in the state. As per the order read as (4) above Government has accorded sanction for granting Professor Placement of teachers in Universities and Colleges in the state coming under 7th UGC scheme from 18.07.2018 onwards, in accordance with the provisions in the UGC Regulation 2018.

As per the circular read as (8) above, the Principals of Government Colleges had submitted the proposals for placement as Professor (Academic Level 14) to this office. According to the provisions in UGC 2018 Regulation, the claims for CAS - Professor (Academic Level 14) have to be approved by the Selection Committee constituted by the Director of Collegiate Education.

As per the order of Director of Collegiate Education read as (9), 35 eligible candidates given placement in the post of Professor (Academic Level 14). The remaining proposals of other teachers were withheld for the detailed scrutiny and concurrence of subject experts. As per the order of Director of Collegiate Education read as (10) above, a Selection Committee had been constituted for furnishing a list of eligible Professor (Academic Level 14) from the remaining proposals. As per Government order read as (5) above the articles to be considered for the placement of Professor were clarified. Also, Government letter read as (6) above states that, an article published before or after entering the service of a teacher can be considered for the CAS placements to the post of Professor.

Based on the order (10) of the Director of Collegiate Education, the Subject Experts verified and

re scrutinized the proposals of various subjects: Malayalam, Hindi, Music, Arabic and Education. After that, subject wise selection committee were held at the chamber of Director Collegiate Education from 12.07.2023 to 20.07.2023.

On the basis of the decision of Selection Committee , 28 eligible applicants were awarded Professor placement (Academic Level 14) in the entry pay of Rs. 1,44,200 /- as given in Annexure to this order.

The placement granted as per this Order is subject to the following conditions.

- **1**. This Order is subject to verification of the Accountant General, Kerala concerned for issuing pay slips.
- 2. If any amount drawn by the incumbent by this Order is found to be in excess due to mistake or any other reason, noticed later, he/she would be liable to refund the amount so received in lump unconditionally.
- 3. The incumbent should submit his/her option and declaration for the fixation of pay within 3 months of this Order to Directorate of Collegiate Education there after to the Accountant General, Kerala (with CTC).
