ORDER

As per paper read as 2<sup>nd</sup> Paper above, the Hon'ble Supreme  
Court dismissed the SLP filed by Government against the common  
judgment dated 08.10.2018 of the Hon'ble High Court in OP (KAT)  
Nos 401/2017, 378/2017, 473/2017, 209/2018, 45/2017, 46/2017,  
69/2017.

The precise of the case of the respondents in judgment read as  
1<sup>st</sup> Paper above is that though they were appointed under Rule 9(a) (i)



of Part II of the Kerala State & Subordinate Services Rules for a period of 179 days from the date of joining pursuant to the respective orders, their appointment is regular as they were virtually recruited regularly through employment exchange after following the regular process of selection. They contended that the Category 4 (b) (ii) of Rule 5 (a) of the Special Rules for Last Grade Service and Part time contingent Services prescribe direct recruitment through employment exchange in the absence of suitable hands under item(i) that provides for promotion of part time contingent employees from the common seniority list prepared by the District Collector on revenue district wise basis. They also prayed for quashing of the orders of their appointment to the extent it limited the period of appointment to 179 days.

The State of Kerala and others filed OP (KAT)s on being aggrieved by the orders passed by the Kerala Administrative Tribunal on different dates, in certain original applications and one Transferred Application, carrying similar issues. O.P(KAT) No.401/2017 is filed against the order dated 02.09.2014 in O.A.No.109/2014, O.P(KAT) No.378/2017 is filed against the order dated 15.6.2017 in O.A. No.1938/2013, O.P(KAT) No.473/2017 is filed against the order dated 10.07.2015 in T.A.No.6355/2012, O.P(KAT) No.209/2018 is filed against the order dated 02.06.2017 in O.A.No.78/2015, O.P(KAT) No.45/2017 is filed against the order dated 29.08.2016 in O.A.No.1484/2015, O.P(KAT) No.46/2017 is filed against the order dated 29.8.2016 in O.A. No.1793/2015 and O.P(KAT) No.69/2017 is filed against the order dated 21.11.2016 in O.A.No. 1455/2015. But by the common judgment dated 8/10/2018 of the Hon'ble High Court of Kerala in OP (KAT) Nos 401/2017, 378/2017, 473/2017, 209/2018, 45/2017, 46/2017, 69/2017, wherein the Hon'ble High Court has dismissed the OP (KAT)s vide judgment read as 1<sup>st</sup> paper above. Therefore Government decided to file SLP against the judgment. But as per reference 2<sup>nd</sup> cited the Special Leave Petition was heard and dismissed by the Hon'ble Supreme court on 3.7.2019. Now as per reference 5<sup>th</sup> and 6<sup>th</sup> cited, the Tribunal has directed the respondents to comply with the directions in the judgment and also ordered personal appearance of the first respondent. As per letter dated 31.8.2019 in reference 3<sup>rd</sup> cited, the Advocate General,



Aruvananthapuram has informed that the case came up for consideration before the Hon'ble Tribunal on 30.8.2019 and the Hon'ble Tribunal vide Order read as 7<sup>th</sup> Paper above has directed the first respondent to appear in person on 2<sup>nd</sup> day of September 2019 at 10.30 am at Court II of Kerala Administrative Tribunal and on subsequent dates to which proceedings are adjourned, unless otherwise ordered by the Tribunal and Show cause why direction should not be issued to the City Police Commissioner to arrest and produce the first respondent before the Tribunal. It may be noted that Review Petition with Diary Number (R.P 31191/2019) has been filed before the Hon'ble Supreme Court and the judgment in the Review Petition is not yet rendered by the Hon'ble Court. As per the letter read as 8<sup>th</sup> Paper above, Government moved for stay of the show cause notice issued by the Tribunal to the first respondent as per Order read as 7<sup>th</sup> Paper above but the stay cannot be obtained within the timeframe ordered by the Tribunal.

In order to avoid adverse remarks from the Hon'ble Tribunal, Government are pleased to order that the temporary appointment of the applicants in O.A.No.109/2014, O.A. No.1938/2013, T.A.No.6355/2012, O.A.No.78/2015, O.A.No.1484/2015, O.A. No.1793/2015 and O.A.No. 1455/2015 are regularised, subject to the outcome of the Review Petition filed before the Hon'ble Supreme Court against Order read as 2<sup>nd</sup> Paper above, and also subject to the following conditions

- (i) The matter impugned in the petition shall not be treated as precedent for other cases.
- (ii) The relief granted to the petitioners is only on the basis of the directions issued by the Hon'ble High Court of Kerala in judgment read as 1<sup>st</sup> Paper above and orders of Hon'ble Supreme Court.
- (iii) This shall be treated as an individual order which cannot be applied generally.

The Judgment dated 8.10.2018 in OP(KAT) No. 45/2017 and other connected cases is thus complied with.

ORDER

The applicants Smt.Anila.K.N and Smt.Bindu.T were appointed through the employment exchange to the post of sweeper and sanitary worker. The Writ petition is filed by the applicants aggrieved by the proceedings initiated to terminate their services and for regularization in the above post. The Hon'ble Tribunal vide order dated 01.08.2018 in TA No.152 of 2013 directed to treat the appointments of the applicants as regular. The OP(KAT) 58/2019 filed against the judgment was also dismissed by the Tribunal vide order dated 15.02.2019 by stating that the issue involved in this original petition is squarely covered by a common judgment of this court dated 08.10.2018 in OP(KAT) No.69 of 2017 and the connected matters and in the light of the said position and in the light of the common judgment in OP(KAT) No.69/2017 and connected matters, this original petition is liable to be failed and accordingly, it is dismissed. Hence SLP was filed against the order dated 15.02.2019 of High Court in OP(KAT) 58/2019

The Director of Collegiate Education as per the letter read as 4<sup>th</sup> paper above

that the SLP(C) No.13579/2019 filed against the judgment dated 15.02.2019 of High Court in OP(KAT) No.58/2019 was dismissed by the Hon'ble Supreme Court. The Advocate General as per the letter read as 7<sup>th</sup> paper above has informed that the applicant has filed MA No.2471/2019 in TA 152/2013 for a direction to the respondents to execute the final order dated 01.08.2018 of the Hon'ble Kerala Administrative Tribunal in TA 152/2013.


Government have examined the matter in detail. As per Government Order read as 6<sup>th</sup> paper above, the temporary appointment of the applicants in O.A No.109/2014, OA No. 1938/2013, T.A No. 6355/2012, OA No.78/2015, OA No.1484/2015, OA No.1793/2015 and OA No. 1455/2015 were regularized subject to the outcome of Review Petition filed before the Hon'ble Supreme Court. Since the SLP(C) No 13579/2019 filed against the judgment dated 15.2.2019 of High Court in OP(KAT) No.58/2019 filed by State against Anila K.N and Smt.Bindu.T was also dismissed by the Supreme court, the temporary appointment of the applicants Smt Anila K.N and Smt.Bindu.T are also regularised subject to the outcome of Review Petition as done in the case of similar applicants and subject to the following conditions.

- i) The matter impugned in the petition shall not be treated as precedent for other cases.
- ii) The relief granted to the petitioners is only on the basis of the directions issued by the Hon'ble High Court of Kerala in judgment read as 1<sup>st</sup> paper above and orders of Hon'ble Supreme Court.
- iii) This shall be treated as an individual order which cannot be applied generally.

### ORDER

The applicants Smt.Sreeja.V, Smt.Girija.D, Smt.Santha.P and Smt.Sushakumari.V were appointed as sweepers and sanitation workers in Government College, Karyavattom through the Employment Exchange for a period of 179 days. Writ Petition W.P(C) No.23261/2010 was filed before the Hon'ble High Court of Kerala with a prayer to regularize their provisional appointment in the posts of Sweeper/Sanitation Worker in Government College, Karyavattom. The Hon'ble Kerala Administrative Tribunal as per paper read as 1<sup>st</sup> Paper above allowed the Transfer Application and directed to treat the appointment of the applicants as regular from the initial date of appointment and that the applicants be sanctioned all consequential benefits including monetary benefits. An OP(KAT) 324/2018 was preferred against the Order read as 1st paper above and the same is pending before the Hon'ble High Court. Stay against the Order read as 1<sup>st</sup> Paper above was also not granted.

OP(KAT)s No.401/2017, 378/2017, 473/2017, 209/2018, 45/2017, 46/2017, 69/2017 were filed against the orders of Hon'ble KAT in similar cases filed by other applicants who were also temporarily

appointed in sweeper/sanitation worker posts in various Government Colleges and the Hon'ble High Court had dismissed these OP(KAT)s by the common judgment dated 08.10.2018 of the Hon'ble High Court in OP(KAT)No.45/2017 and other connected cases. SLP(C) No.15928/2019 was filed against the common judgment and also as per order dated 03.07.2019 in SLP(C)No.15928/2019 and other connected cases, the SLP was also dismissed by the Hon'ble Supreme Court . Accordingly as per Government Order read as 3rd paper above, the temporary appointment of applicants in O.A No. 109/2014, OA No.1938/2013, T.A No 6355/2012, OA No.78/2015, OA No.1484/2015 OA No. 1793/2015 and OA No.1455/2015 were regularised subject to the outcome of the Review Petition RP (C) No.31191/19 filed before the Hon'ble Supreme Court against the Order dated 03.07.2019 in SLP (C)No.15928/2019 and other connected cases.The Review Petition RP (C) No. 31191/19 was also dismissed by the Hon'ble Supreme Court.

The applicants in TA 5707/2012, filed MA No.1471/2021 in TA 5707/2012 with a prayer to the Hon'ble Tribunal to direct the respondents to implement the directions issued by the Tribunal in Order read as 1st Paper above. As per order dated 1.11.2021 in MA No.1471/2021 in TA 5707/2012, it was directed to report compliance of order read as 1st paper above. An extension of time requested for compliance was refused by the Hon'ble KAT and the Tribunal directed to implement the order read as 1st paper above , subject to the outcome of OP(KAT) 324/2018 as per order dated 15.12.2021 in MA-1471/2021 in TA 5707/2012.

Now as per order dated 25.02.2022 in MA No.1471/2021 in TA 5707/2012 the Tribunal has directed the first respondent to appear in person on 15.03.2022 and explain why contempt action should not be taken against him or by framing charges against him for having deliberately disobeyed the direction of the Tribunal.

In order to avoid adverse remarks from the Hon'ble Tribunal, Government are pleased to order that the temporary appointment of the applicants in TA 5707/2012 are regularised as per the Order read as 1st paper above, subject to the outcome/final judgment in OP (KAT) 324/2018 filed against the order read as 1<sup>st</sup> Paper cited above and also subject to the following conditions:

- (i) The matter impugned in the petition shall not be treated as precedent for other cases.
- (ii) The relief granted to the petitioners is only on the basis of the directions issued by the Hon'ble Tribunal in order read as 1st paper



above.

(iii) This shall be treated as an individual order which cannot be applied generally.

(iv) If the District Collector forwards the names of persons eligible for promotion on the date of occurrence of vacancies which were reported to the Employment Exchange, the appointments of the applicants can be reviewed, provided there are no vacancies to accommodate those persons found eligible for promotion.

The applicant has been appointed as Sweeper in the Government College, Karyavattom in Thiruvananthapuram District in pursuance of the order dated 01/02/2010 issued by the Principal, Government College, Karyavattom for a period of 179 days. She was selected from a list of persons forwarded by various Employment Exchanges in the Thiruvananthapuram District.

2. The post of Sweeper belongs to Kerala Last Grade Service and the same is included as item No.(a) in Category 4 of the Special Rules for the Kerala Last Grade Service and hence the method of appointment provided in the Special Rules is applicable to the appointment of the applicant.




3. It is submitted that two methods are provided in the Special Rules for the appointment of Sweepers and Sanitation Workers; (i) by promotion of part time contingent employees from the common seniority list prepared by the District Collector on Revenue District basis and (ii) in the absence of suitable hands under the said item, by direct recruitment by Employment Exchange.
4. It is submitted that no seniority list of eligible part time contingent employees was available as on the date on which the Employment Exchange sponsored the name of the applicant. In the sad circumstances, applicant along with three other similarly appointed candidates approached the Hon. High Court and filed the Writ Petition as WP(C) No. 23261 of 2010, praying to quash the appointment orders to the extent to which it limits their appointment only for a period of 179 days by treating it's as provisional and for other relieves. The said Writ Petition was transferred to Hon. Kerala Administrative Tribunal, Thiruvananthapuram as TA 5707 of 2012. The Hon. Tribunal was pleased to pass an Order allowing the said TA as per the order dated 29.11.2017.
5. The Hon. Tribunal has held that, *"In the view of the matter, the orders Exts. P1 to P4 to the extent to which the period of appointment of the applicants is restricted as 179 days cannot be supported and their appointment will be treated as regular instead of temporary as described in those orders. The applicant will also therefore be entitled for all consequential service benefits including monetary benefits. Appropriate orders will be issued treating their appointment as regular from initial date of appointment, namely Exts. P1 to P4 itself, and the consequential monetary benefits will be sanctioned and disbursed to them within a period of two months from the date of receipt of a certified copy of this order."* A true copy of the said Order dated 29/12/2017, passed by the Honourable Kerala Administrative Tribunal in TA 5707 of 2012 is produced herewith as Annexure A1.





6. Though the respondents therein preferred an OP(KAT) as 324 of 2018 before the Hon. High Court of Kerala challenging the Annexure A1 Order, the Hon. High Court did not pass any order staying the operation or implementation of the same.
7. As the respondents have willfully avoided the implementation of the Annexure A1 Order, the applicants therein, including the applicant moved MA 1471 of 2021 seeking execution of the said Order dated 29/11/2017. In pursuance of the several orders issued by the Hon. Tribunal in the said MA, the respondents were constrained to pass an Order regularizing the service of the applicant and other three candidates with effect from the date of their initial appointment. A true copy of the Order bearing G.O.(Rt) No. 409/2022/HEDN dated 11/03/2022 passed by the first respondent regularizing the service of the applicant with effect from the date of her initial appointment is produced herewith as Annexure A2.
8. It is submitted that the applicant is entitled to get reckoned her seniority in service with effect from 01/02/2010, the date of her entry into service as the Hon. Tribunal has unequivocally declared in the Annexure A1 Order that ***"The applicant will also therefore be entitled for all consequential service benefits including monetary benefits"***. But the respondents have shown willful abstinence in including the name of the applicant in the seniority list of Office Attendant/Night Watchman/Markers/Sweeper for promotion to the post of Attender, despite several requests from her part.
9. In this regard, it is pertinent to note that a number of candidates who are having lesser service than the applicant has already been promoted to the post of Attender on the basis of the seniority list published as C4/20099/16/CE dated 08/09/2016 by the Senior Administrative Officer, Collegiate Education Department. A true copy of the relevant pages of the said seniority list published as C4/20099/16/CE dated 08/09/2016 by the Senior Administrative Officer, Collegiate Education Department is produced herewith as Annexure A3.



10. It is submitted that considering the length of service of the applicant from 01/02/2010, she ought to have been placed as Rank No. 105 in the Annexure A3 seniority list. However, the respondents willfully evaded from implementing the Annexure A1 order in its correct perspective and from making necessary corrections in the Annexure A3 seniority list. It is pertinent to note that, the candidate ranked as 307 in the said seniority list, who joined service only on 07/02/2014 was granted promotion and posting in Thiruvananthapuram District on the basis of the said seniority list.

11. It is submitted that several number of vacancies are now available in the Collegiate Education Department in the post of Attender for promotion from among the Office Attendant/Night Watchman/Markers/Sweeper. In case the Annexure A1 order is properly implemented by the respondent granting seniority from 01/02/2010, the date of her appointment, the applicant will be able to get the promotion to one of the said available vacancies in Thiruvananthapuram District.

12. While so, the second respondent published a provisional seniority list of Sweeper/Sanitation Worker/Cook as per the Circular bearing No. C6/527/2023/DCE dated 30/01/2023 without including the name of the applicant in appropriate place, considering her seniority. A true copy of the said Circular bearing No. C6/527/2023/DCE dated 30/01/2023 along with the provisional seniority list of Sweeper/Sanitation Worker/Cook as on 30/06/2021, published by the second respondent is produced herewith as Annexure A4.

13. Being highly aggrieved by the exclusion of her name in the seniority list considering her long service from 01/02/2010, the applicant submitted a representation dated 01/02/2023, before the second respondent through the third respondent, requesting to include her name in the Annexure A4 provisional seniority list. A true copy of the said representation dated 01/02/2023 submitted by the applicant before the second respondent is produced herewith as Annexure A5.

14. It is submitted that, even after the expiry of more than four months from the date of publication of Annexure A4 provisional seniority list and the Annexure A5 representation submitted by the applicant, so far there is no positive move on the part of the respondents in redressing the grievance of the applicant by rectifying the defects crept in the Annexure A4 provisional seniority list and to rank the applicant according to her seniority in service.


15. The applicant bonafide apprehends that, her claim for reckoning her seniority from the date of her appointment, in the light of the Annexure A1 final Order passed by this Honourable Tribunal will not be considered for extraneous reasons. There are strong and reasonable grounds for the applicant to have such an apprehension as she had already experienced the same in the matter of implementation of Annexure A1 final order passed by this Hon. Tribunal dated 29/11/2017. Though the Annexure A1 was passed as early as on 29/11/2017, the respondent took almost five years to comply the same.

16. In the above said circumstances, the applicant has left with no other alternative measures than to approach this Hon. Tribunal for the redressal of her grievance. Hence this Original Application.

**7. GROUNDS FOR RELIEF WITH LEGAL PROVISIONS:**

- A. The publication of Annexure A4 provisional seniority list of Sweeper/Sanitation Worker/Cook as on 30/06/2021 by the second respondent as per the Circular bearing No. C6/527/2023/DCE dated 30/01/2023, without including the applicant considering her seniority in service is highly unjust, illegal and arbitrary.
- B. The second respondent has published the Annexure A4 provisional seniority list without considering the Annexure A2 order passed by the first respondent regularizing the service of the applicant with effect from 01/02/2010.






- C. The second respondent ought to have found that the Hon. Tribunal as per Annexure A1 order has held that *"In view of the matter, the orders Exts. P1 to P4 to the extent to which the period of appointment of the applicants is restricted as 179 days cannot be supported and their appointment will be treated as regular instead of temporary as described in those orders. The applicant will also therefore be entitled for all consequential service benefits including monetary benefits"*. In the light of the said order granting all consequential service benefits by the Hon. Tribunal, the respondents ought to have reckoned the service seniority of the applicant from 01/02/2010, the date of her appointment.
- D. It is pertinent to note that, solely due to the lapses on the part of the respondents, the applicant has lost the chances of promotion on the date on which she became qualified considering her seniority and also that several candidates with lesser service when compared to the applicant have already been granted promotion bypassing the applicant. If the Annexure A1 order passed by the Hon. Tribunal had been properly implemented by the respondents in right time, the applicant would not have lost the said promotion chances.
- E. The respondents ought to have placed the applicant in the appropriate rank in the Annexure A4 provisional seniority list by reckoning her seniority from 01/02/2010, the date of her appointment.
- F. The second respondent ought to have published the final seniority list in pursuance of the Annexure A4 provisional seniority list after making necessary corrections in the same as prayed for by the applicant in the Annexure A5 representation and the respondents ought to have effected promotion as there exists sufficient number of vacancies to effect promotions.

G. 



**RELIEF**







ORDER

The applicants/petitioners herein have a common grievance and they are seeking to quash Exts.P1 to P4 orders to the extent to which they limit their appointment only for a period of 179 days by treating it as provisiional. They are seeking for a further direction to the respondents to regularise them in service forthwith.

2. The applicants have been appointed as Sweepers and Sanitation Workers respectively in the Government College, Karyavattom in Thiruvananthapuram. Exts.P1 to P4 are the copies of the appointment orders dated 1.2.2010. They were selected from a list of persons forwarded by various Employment Exchanges in the district.

3. It is pointed out further that the posts of Sanitary Worker and Sweeper belong to the Kerala Last Grade Service. It is included as item No. (a) in Category 4 of the Special Rules for the Kerala Last Grade Service. Therefore, the method of appointment provided in the Special Rules is applicable to the appointment of the applicants.

4. Two alternative methods of appointment are provided

therein; (i) by promotion of part time contingent employees from the common seniority list prepared by the District Collector on Revenue District basis and (ii) in the absence of suitable hands under the said item, by direct recruitment by employment exchange.

5. The only question therefore is whether their appointment could be limited to 179 days. The applicants rely upon the judgment of the Hon'ble High Court in W.A.No.491 of 2000 to advance the said argument.

6. The learned counsel for the applicants submitted that in O.A.No.1449 of 2012 a similar question was considered by this Tribunal in relation to an appointee, who was a Sanitation Worker in the C.K.G.Memorial Government College, Perambra. Therein also the appointment was for a period of 179 days. It was held in the said order that the legal point is covered by the order passed by this Tribunal in O.A.No.616 of 2012.

7. The learned counsel further submitted that the reply statement of the second respondent will not show that any seniority list of eligible part time contingent employees was available.

8. A reference to the contentions raised in the reply statement will show that the plea raised is that their appointment was on temporary basis for a period of 179 days through the Employment Exchange. It is also stated that the list of qualified hands was sponsored by the District



Employment Officer, Thiruvananthapuram. They were appointed in the full time posts of Sanitation Workers and Sweepers. That the posts of Sanitation Worker and Sweeper are included as item No.(a) in Category 4 of the Special Rules is stated in paragraph 3 and the method of appointment has also been reiterated therein. The averments further made in the reply statement do not reflect that any seniority list of such part time contingent employees in the department was available as on the date on which the officers of the Employment Exchanges sponsored the names of the applicants. It is stated that 9 part-time contingent employees were promoted and two were reverted and allowed to continue as part time and the seniority list was in the process of preparation. Therein, the contention raised appears to be that their appointment is only purely temporary.

9. The Division Bench of the Hon'ble High Court in Ext.P5 judgment has considered a similar question. Therein the question raised was whether the department was justified in appointing the petitioners on a provisional basis despite the fact that they had been duly selected by the selection committee and as per the conditions for direct recruitment. They were sponsored by the Employment Exchange. The Rules in question, namely the Kerala Last Grade Service Rules, were examined. It was held in paragraph 5 of the judgment after referring to the Rules, that 50% of the posts have to be filled up by promotion of 'part-time contingent employees' working in any of the departments

mentioned in sub-clause (1) and the remaining 50% have to be filled up by promotion from the candidates advised by the District Collectors. In case suitable candidates are not available from sources (i) and (ii), the appointment has to be made by 'direct recruitment' through the Employment Exchange. After having held so, it was further held in paragraph 7 that the appointment of the petitioners was in strict conformity with the provisions of Rule 3(a)(iii) of the Special Rules. Finally, it was found that the appointments cannot be treated as provisional and the benefits were granted to the petitioners therein.

10. This Tribunal in paragraph 3 of the order in O.A.No.1409 of 2012 has quoted the operative portion of the order in O.A.No.616 of 2012, which is extracted herein below:

"We notice that the above decision applies on all the fours to the facts of this case. So, following the said decision, this O.A. is allowed. It is ordered that the appointment of the applicant shall be treated as regular. But, in case if the District Collector forwards the names of persons eligible for promotion as Sweeper and if those persons were qualified for promotion on the date of occurrence of the vacancy, which was reported to the Employment Exchange, the appointment of the applicant can be reviewed, provided there are no vacancies to accommodate those persons sponsored by the District Collector. Original Application is disposed of as above."

The said OA was allowed in terms of the said direction and the



applicant's appointment was held as regular.

11. The learned Government Pleader submitted that the stand of the respondents is that the appointment of the applicants is purely temporary, namely for 179 days. But in the light of the legal position explained above, as persons eligible for promotion were not available, at the time of appointment, there cannot be any restriction by prescribing the period of appointment as 179 days. The regular method of appointment as per the Kerala Last Grade Service Rules has been adopted.

12. In that view of the matter, the orders Exts.P1 to P4 to the extent to which the period of appointment of the applicants is restricted as 179 days cannot be supported and their appointment will be treated as regular instead of temporary as described in those orders. The applicants will also therefore be entitled for all consequential service benefits including monetary benefits. Appropriate orders will be issued treating their appointment as regular from the initial date of appointment, namely Exts.P1 to P4 itself, and the consequential monetary benefits will be sanctioned and disbursed to them within a period of two months from the date of receipt of a certified copy of this order. It is made further clear that if the District Collector forwards the names of persons eligible for promotion on the date of occurrence of vacancies which were reported to the Employment Exchange, the


appointments of the applicants can be reviewed, provided there are no vacancies to accommodate those persons found eligible for promotion.

### **ORDER**

The applicants Smt.Sreeja.V, Smt.Girija.D, Smt.Santha.P and Smt.Sushakumari.V were appointed as sweepers and sanitation workers in Government College, Karyavattom through the Employment Exchange for a period of 179 days. Writ Petition W.P(C) No.23261/2010 was filed before the Hon'ble High Court of Kerala with a prayer to regularize their provisional appointment in the posts of Sweeper/Sanitation Worker in Government College, Karyavattom. The Hon'ble Kerala Administrative Tribunal as per paper read as 1<sup>st</sup> Paper above allowed the Transfer Application and directed to treat the appointment of the applicants as regular from the initial date of appointment and that the applicants be sanctioned all consequential benefits including monetary benefits. An OP(KAT) 324/2018 was preferred against the Order read as 1st paper above and the same is pending before the Hon'ble High Court. Stay against the Order read as 1<sup>st</sup> Paper above was also not granted.

OP(KAT)s No.401/2017, 378/2017, 473/2017, 209/2018, 45/2017, 46/2017, 69/2017 were filed against the orders of Hon'ble KAT in similar cases filed by other applicants who were also temporarily


appointed in sweeper/sanitation worker posts in various Government Colleges and the Hon'ble High Court had dismissed these OP(KAT)s by the common judgment dated 08.10.2018 of the Hon'ble High Court in OP(KAT)No.45/2017 and other connected cases. SLP(C) No.15928/2019 was filed against the common judgment and also as per order dated 03.07.2019 in SLP(C)No.15928/2019 and other connected cases, the SLP was also dismissed by the Hon'ble Supreme Court. Accordingly as per Government Order read as 3rd paper above, the temporary appointment of applicants in O.A No. 109/2014, OA No.1938/2013, T.A No 6355/2012, OA No.78/2015, OA No.1484/2015 OA No. 1793/2015 and OA No.1455/2015 were regularised subject to the outcome of the Review Petition RP (C) No.31191/19 filed before the Hon'ble Supreme Court against the Order dated 03.07.2019 in SLP (C)No.15928/2019 and other connected cases. The Review Petition RP (C) No. 31191/19 was also dismissed by the Hon'ble Supreme Court.

The applicants in TA 5707/2012, filed MA No.1471/2021 in TA 5707/2012 with a prayer to the Hon'ble Tribunal to direct the respondents to implement the directions issued by the Tribunal in Order read as 1st Paper above. As per order dated 1.11.2021 in MA No.1471/2021 in TA 5707/2012, it was directed to report compliance of order read as 1st paper above. An extension of time requested for compliance was refused by the Hon'ble KAT and the Tribunal directed to implement the order read as 1st paper above, subject to the outcome of OP(KAT) 324/2018 as per order dated 15.12.2021 in MA-1471/2021 in TA 5707/2012.

Now as per order dated 25.02.2022 in MA No.1471/2021 in TA 5707/2012 the Tribunal has directed the first respondent to appear in person on 15.03.2022 and explain why contempt action should not be taken against him or by framing charges against him for having deliberately disobeyed the direction of the Tribunal.

In order to avoid adverse remarks from the Hon'ble Tribunal, Government are pleased to order that the temporary appointment of the applicants in TA 5707/2012 are regularised as per the Order read as 1st paper above, subject to the outcome/final judgment in OP (KAT) 324/2018 filed against the order read as 1<sup>st</sup> Paper cited above and also subject to the following conditions:

- (i) The matter impugned in the petition shall not be treated as precedent for other cases.
- (ii) The relief granted to the petitioners is only on the basis of the directions issued by the Hon'ble Tribunal in order read as 1st paper

(iii) This shall be treated as an individual order which cannot be applied generally.

(iv) If the District Collector forwards the names of persons eligible for promotion on the date of occurrence of vacancies which were reported to the Employment Exchange, the appointments of the applicants can be reviewed, provided there are no vacancies to accommodate those persons found eligible for promotion.


