**ORDER**

As per the Government Orders read as 1<sup>st</sup> and 2<sup>nd</sup> above, Government had implemented UGC 7<sup>th</sup> scheme in the State. Government had accorded sanction for granting placement of Teachers in Universities and Colleges in the State coming under 7<sup>th</sup> UGC Scheme from 18/07/2018 onwards, in accordance with the provisions in the UGC Regulations, 2018.

As per the provisions in UGC 2018 regulations, the claims for CAS (Assistant Professor Stage 2 and stage 3) has to be approved by the Screening cum evaluation committee constituted at the Colleges concerned.

As per the letters read as 6<sup>th</sup> above, the Principals of Government Colleges have submitted the proposals for placement as Assistant Professor Stage 3 in respect of the teacher (1 No.) mentioned below, with recommendation of the Screening Committee constituted at the Colleges.

In these circumstances, the placement as Assistant Professor Stage 3 (Academic Level 12) in respect of the teachers of Government Colleges is granted as given in Annexure to this Order.

The placement granted as per this Order is subject to the following conditions.

1. This Order is subject to verification of the Accountant General Kerala concerned for issuing pay slips.
2. If any amount drawn by the incumbent by this Order is found to be in excess due to mistake or any other reason, noticed later, he/she would be liable to refund the amount so received in lump unconditionally.
3. The incumbent should submit his/her option and declaration for the fixation of pay within three

months of this Order first to the respective office and thereafter to the Accountant General concerned with CTC.
