**ORDER**

As per the Notification read as 3<sup>rd</sup> above, the UGC Regulations 2018 came into force. As per the Government Orders read as 2<sup>nd</sup> above, Government has implemented UGC 7<sup>th</sup> scheme in the State. The Career Advancement Scheme (CAS), that is, Placement and Promotion of teachers have effect from 18/07/2018.

Subsequently Government of Kerala vide G.O.(Rt.) No.724/2020/H.Edn dated 5/6/2020 has given sanction for granting placement of teachers of Colleges and Universities coming under the 7<sup>th</sup> UGC Scheme from 18.07.2018 onwards, in accordance with the provisions in the UGC Regulations 2018.

As per the provisions in UGC regulations 2018, the claims for CAS (Associate Professor) has to be approved by the Selection Committee.

As per the letters read as 6<sup>th</sup> above, the Principals of Government Colleges have submitted the proposals of teachers for placement as Associate Professor. Their Proposals for placement as Associate Professor were submitted to the selection committee held at Govt College For Women, Thiruvananthapuram on 22.11.2023. The Selection Committee after examination resolved to approve their placement as Associate Professor with effect from the date mentioned against each teacher.

In the circumstances, the placement as Associate Professor in respect of the teachers (**13 nos**) in Botany of Government Colleges is granted as given in Annexure to this Order.

The placement granted as per this Order is subject to the following conditions.

1. This Order is subject to verification of the Accountant General Kerala concerned for issuing pay slips and genuineness of PhD certificates.
2. If any amount drawn by the incumbent by this Order is found to be in excess due to mistake or any

other reason, noticed later, he/she would be liable to refund the amount so received in lump unconditionally.

3. The incumbent should submit his/her option and declaration for the fixation of pay within three months of this Order to the Accountant General concerned (with CTC ).
