ORDER

As per the Government Orders read as 1st and 2nd above, Government has implemented UGC 7th scheme in the State. Government has also accorded sanction for granting placement of Teachers in Universities and Colleges in the State coming under 7th UGC Scheme from 18/07/2018 onwards, in accordance with the provisions in the UGC Regulations, 2018.

As per the provisions in UGC 2018 regulations, the claims for CAS (Assistant Professor Stage 2 and stage 3) has to be approved by the Screening cum evaluation committee constituted at the Colleges concerned.

As per the letters read as 7 above, the Principals of Govt. Colleges have submitted the proposals for placement as Assistant Professor Stage 3 in respect of the teachers (**9 No.s**) mentioned below, with recommendation of the Screening Committee constituted at the Colleges.

In the circumstances, the placement as Assistant Professor Stage 3 (Academic Level 12) in respect of the following teachers of Government Colleges as given in Annexure 1 is granted.

The placement granted as per this Order is subject to the following conditions.

1. This Order is subject to verification of the Accountant General Kerala concerned for issuing pay slips.
2. If any amount drawn by the incumbent by this Order is found to be in excess due to mistake or any other reason, noticed later, he/she would be liable to refund the amount so received in lump unconditionally.
3. The incumbent should submit his/her option and declaration for the fixation of pay within three months of this Order to the Accountant General (with CTC) concerned.
