**ORDER**

As per the Notification read 3<sup>rd</sup> above, the UGC Regulations 2018 came into force. As per the Government Order read 2<sup>nd</sup> above, Government has implemented UGC 7<sup>th</sup> scheme in the State. The Career Advancement Scheme (CAS), that is, Placement and Promotion of teachers came into effect from 18/07/2018.

As per the provisions in UGC 2018 regulations, the claims for CAS (Assistant Professor Stage 2 and stage 3) has to be approved by the Screening cum Evaluation Committee constituted at the Colleges concerned.

As per the letters read as 6<sup>th</sup> above, the Principals of Government Colleges have submitted the proposals for placement as Assistant Professor Stage 3 in respect of the teachers mentioned below, with recommendation of the Screening cum Evaluation Committee constituted at the Colleges.
