ORDER

As per the Notification read (3) above, the UGC Regulations 2018 came into force. As per the Government Order read (2) above, Government has implemented UGC 7th scheme in the State. The Career Advancement Scheme (CAS), that is, Placement and Promotion of teachers came into effect from 18/07/2018.

As per the provisions in UGC 2018 regulations, the claims for CAS (Assistant Professor Stage 2 and stage 3) has to be approved by the Screening cum Evaluation Committee constituted at the Colleges concerned.

As per the letters read (6) above, the Principals of Government Colleges have submitted the proposals for placement as Assistant Professor Stage 3 in respect of the teachers mentioned below, with recommendation of the Screening cum Evaluation Committee constituted at the Colleges.
