**ORDER**

As per the Notification read (3) above, the UGC Regulations 2018 came into force. As per Government Order read (2) above, Government has implemented UGC 7th scheme in the State. The Career Advancement Scheme (CAS), that is, Placement and Promotion of

teachers came into effect from 18/07/2018.

Subsequently Government of Kerala vide G.O.(Rt.) No.724/2020/H.Edn dated 05/06/2020 has given sanction for granting Placement of Teachers of Colleges and Universities coming under the 7th UGC Scheme from 18.07.2018 onwards, in accordance with the provisions in the UGC Regulations 2018. As per the provisions in UGC regulations 2018, the claims for CAS Promotion (Associate Professor) Academic Level 13A has to be approved by the Selection Committee.

As per the letters read (6) above, the Principals of Government Colleges have submitted the proposals of teachers for placement as Associate Professor Academic Level 13A. Their Proposals for placement as Associate Professor were submitted to the Selection Committee held as per read (8) above. The Selection Committee after examination, resolved to approve eligible placement proposals as Associate Professor Academic Level 13A with effect from the date mentioned against each teacher.

As per the Order read (9) above, Placement was granted to the following faculties, under the 7th UGC Scheme and some errors crept in the above mentioned order. Accordingly rectifying Order is hereby issued as per the request received vide reference (10) and 11) above.

The following faculties are given Placements, subject to the conditions, as Associate Professor (Option B, Commerce) in the scale of Pay of Rs. 131400-217100 from the date mentioned against each under the VIIth UGC Scheme vide GO(P)No.18/2019/H.Edn dated 29.06.2019.
