**ORDER**

As per Government Orders read (1) and (2) above, Government has implemented UGC 7 th scheme in the State. Government has accorded sanction for granting placement of Teachers in Universities and Colleges in the State coming under 7 th UGC Scheme from 18/07/2018 onwards, in accordance with the provisions in the UGC Regulations 2018.
