**ORDER**

As per the Government Orders read as 1<sup>st</sup> and 2<sup>nd</sup> above, Government has implemented UGC 7<sup>th</sup> scheme in the State. Government has accorded sanction for granting placement of Teachers in Universities and Colleges in the State coming under 7<sup>th</sup> UGC Scheme from 18/07/2018 onwards, in accordance with the provisions in the UGC Regulations, 2018.

As per the provisions in UGC 2018 regulations, the claims for CAS (Assistant Professor Stage 2 and stage 3) has to be approved by the Screening cum evaluation committee constituted at the Colleges concerned.

As per the letters read as 6 above, the Principals of Government Colleges have submitted the proposals for placement as Assistant Professor Stage 2 in respect of the teacher mentioned below, with recommendation of the Screening Committee constituted at the Colleges.

In the circumstances, based on the recommendations of the College level Screening cum Evaluation Committee, the following faculties are given Placements, subject to the conditions, as Assistant Professor Academic level 11 (stage 2) with rationalized Entry Pay Rs.68,900/- from the date mentioned against each, under the 7<sup>th</sup> UGC Scheme vide G.O(P) No.18/2019/H.Edn dated 29/06/2019.

If any undisclosed LWA/Service Break/other facts in the placement proposal, noticed later (during service or post retirement), this placement and further placements of the concerned incumbent/s shall be invalid. Such extra/undeserved financial benefits enjoyed along with the said placements should either be refunded or to be recovered from the incumbent/s along with penal interest. Revised placement proposals should be submitted in such cases for its regularization.
