ORDER

As per the Notification read (3) above, the UGC Regulations 2018 came into force. As per the Government Order read (2) above, the Government has implemented UGC 7th scheme in the State. The Career Advancement Scheme (CAS), that is, Placement and Promotion of teachers came into effect from 18/07/2018.

As per the provisions in UGC 2018 regulations, the claims for CAS (Assistant Professor Stage 2 and stage 3) has to be approved by the Screening cum Evaluation Committee constituted at the Colleges concerned.
