**ORDER**

As per the Government Orders read as (1) and (2) above, Government has implemented UGC 7th scheme in the State. 2. If any amount drawn by the incumbent by this Order is found to be in excess due to mistake or any other reason, noticed later, he/she would be liable to refund the amount so received in lump sum unconditionally.
3. The incumbent should submit his/her option and declaration for the fixation of pay within three months of this Order first to the respective office and thereafter to the Accountant General concerned with CTC.
4. If any undisclosed LWA/Service Break in the placement proposal, noticed later (during service or post retirement), this placement and further placements of the concerned incumbent/s shall be invalid. Such extra/undeserved financial benefits enjoyed along with the said placements should either be refunded or recovered along with penal interest. Revised placement proposals should be submitted in such cases for its regularization.
