ORDER

As per the Government Orders read (1) and (2) above, Government has implemented UGC 7 th scheme in the State. Government has accorded sanction for granting placement of Teachers in Universities and Colleges in the State coming under 7 th UGC Scheme from 18/07/2018 onwards, in accordance with the provisions in the UGC Regulations 2018.

As per the provisions in UGC 2018 regulations, the claims for CAS (Assistant Professor Stage 2 and stage 3) has to be approved by the Screening cum Evaluation Committee constituted at the Colleges concerned. As per the letters read (6) above, the Principals of Government Colleges have submitted the proposals for placement as Assistant Professor Stage 3, with recommendation of the Screening cum Evaluation Committee constituted at the Colleges.

In the circumstances, based on the recommendation of the Screening cum Evaluation Committee constituted at the Colleges concerned, the eligible 2 faculties are given Placements, subject to the conditions, as Assistant Professor Academic level 12 (stage 3) with rationalized Entry Pay Rs.79,800/- from the date mentioned against each under the 7th UGC Scheme vide G.O(P) No.18/2019/H.Edn dated 29/06/2019 as given in the Annexure 1 to this order.

The placement granted as per this Order is subject to the following conditions.

1. This Order is subject to verification of the Accountant General Kerala concerned for issuing pay slips.
2. If any amount drawn by the incumbent by this Order is found to be in excess due to mistake or any other reason, noticed later, he/she would be liable to refund the amount so received in lump sum unconditionally.
3. The incumbent should submit his/her option and declaration for the fixation of pay within three months of this Order first to the respective office and thereafter to the Accountant General concerned with CTC.
