Order

As per the Notification read as 3 rd above, the UGC Regulations 2018 came into force. As per Government Order read as 2^{n d} above, Government has implemented UGC 7th scheme in the State. The Career Advancement Scheme (CAS), that is, Placement and Promotion of teachers came into effect from 18/07/2018.

Subsequently, Government of Kerala vide G.O.(Rt.) No.724/2020/H.Edn dated 05/06/2020 has given sanction for granting placement of teachers of Colleges and Universities coming under the 7th UGC Scheme from 18.07.2018 onwards, in accordance with the provisions in the UGC Regulations 2018.
