ORDER

As per the Government Orders read as 1st and 2nd above, Government has implemented UGC 7th scheme in the State. As per the Government Orders read as 4th above, Government has accorded sanction for granting Associate Professor Placement of teachers in Universities and Colleges in the State coming under 7th UGC scheme from 18.7.2018 onwards, in accordance with the provisions in the UGC Regulation 2018.

As per the circular read as 8th above, the Principals of Government Colleges have submitted the proposals for placement as Associate Professor (Academic Level 13 A) to this office. According to the provisions in UGC 2018 Regulation, the claims for CAS-Professor (Academic-Level 13A) have to be approved by the selection Committee constituted by the Director of Collegiate Education.

As per the order of the Director of Collegiate Education read as 10th above, eligible candidates were given placement in the post of Associate Professor (Academic Level 13A). As per Government order read as 5th above, the articles to be considered for the placement of Associate Professor were clarified. Also, Government letter read as 6th above states that, an article published before or after entering the service of a teacher can be considered for the CAS placements to the post of Associate Professor.

The Subject Experts verified and scrutinized the proposal of various subjects. After that subject wise selection committees were held at Government Arts College, Trivandrum on 19.03.2024, 20.03.2024, 20.07.2024, 23.07.2024 and 25.07.2024.

On the basis of the decision of Selection Committee, 32 eligible applicants were awarded Associate Professor Placement (Academic Level 13A) in the scale of Pay of Rs. 131400-217100/ -as given Annexures.
