**ORDER**

As per the Government Orders read as 1<sup>st</sup> and 2<sup>nd</sup> above, Government has implemented UGC 7<sup>th</sup> scheme in the State. As per the Government orders read as 4<sup>th</sup> above, Government has accorded sanction for granting Associate Professor Placement of teachers in Universities and Colleges in the State coming under 7<sup>th</sup> UGC scheme from 18.7.2018 onwards, in accordance with the provisions in the UGC Regulation 2018.

As per the circular read as 7<sup>th</sup> above, the Principals of Government Colleges have submitted the proposals for placement as Associate Professor (Academic Level 13 A) to this office. According to the provisions in UGC 2018 Regulation, the claims for CAS - Associate Professor (Academic-Level 13A) have to be approved by the selection Committee constituted by the Director of Collegiate Education.

As per the minutes of the Selection Committee Meeting read as 10<sup>th</sup> above, eligible candidates were given placement in the post of Associate Professor (Academic Level 13A - Option A).
