ORDER

As per the Government Orders read as 1st and 2nd above, Government has implemented UGC 7th scheme in the State. As per the Government orders read as 4th above, Government has accorded sanction for granting Associate Professor Placement of teachers in Universities and Colleges in the State coming under 7th UGC scheme from 18.7.2018 onwards, in accordance with the provisions in the UGC Regulation 2018.

As per the circular read as 7th above, the Principals of Government Colleges have submitted the proposals for placement as Associate Professor (Academic Level 13 A) to this office. According to the provisions in UGC 2018 Regulation, the claims for CAS - Associate Professor (Academic-Level 13A) have to be approved by the selection Committee constituted by the Director of Collegiate Education.

As per the minutes of the Selection Committee Meeting read as 10th above, eligible candidates were given placement in the post of Associate Professor (Academic Level 13A - Option A).

The Subject Experts verified and scrutinised the proposal of various subjects. After that subject wise selection committees were held at University College, Thiruvananthapuram shown below:
