ORDER

As per the Government Orders read as 1st and 2nd above, Government has implemented UGC 7th scheme in the State. As per Government Orders read as 4th above, Government has accorded sanction for granting Professor Placement of teachers in Universities and Colleges in the State coming under 7th UGC scheme from 18.07.2018 onwards, in accordance with the provisions in the UGC Regulation 2018.

As per the circular read as 8th above, the Principals of Government Colleges have submitted the proposals for placement as Professor (Academic Level 14) to this office. According to the provisions in UGC 2018 Regulation, the claims for CAS-Professor (Academic-Level 14) have to be approved by the selection Committee constituted by the Director of Collegiate Education.

Selection committees were convened. The Subject Experts verified and scrutinized the proposal of various subjects. After that subject wise selection committees were held at University College, Thiruvananthapuram.

On the basis of the decision of Selection Committee, the following applicants were awarded Professor Placement (Academic Level 14) in the entry pay of Rs.1,44,200/-.
