**ORDER**

As per the Government Orders read as 1<sup>st</sup> and 2<sup>nd</sup> above, Government has implemented UGC 7<sup>th</sup> scheme in the State. As per the Government Orders read as 4<sup>th</sup> above, Government has accorded sanction for granting Professor Placement of teachers in Universities and Colleges in the State coming under 7<sup>th</sup> UGC scheme from 18.7.2018 onwards, in accordance with the provisions in the UGC Regulation 2018.

As per the circular read as 8<sup>th</sup> above, the Principals of Government Colleges have submitted the proposals for placement as Professor (Academic Level 14) to this office. According to the provisions in UGC 2018 Regulation, the claims for CAS-Professor (Academic-Level 14) have to be approved by the selection Committee constituted by the Director of Collegiate Education.

As per the order of the Director of Collegiate Education read as 10<sup>th</sup> above, eligible candidates were given placement in the post of Professor (Academic

Level 14). The selection committees of various subjects were convened. The Subject Experts verified and scrutinized the proposals. After that subject wise selection committees were held at University College, Thiruvananthapuram from 24.02.2025 to 22.03.2025

On the basis of the decision of Selection Committees, the following applicants were awarded Professor Placement (Academic Level 14) in the entry pay of Rs.1,44,200/-.
