ORDER

As per the Government Orders read as (1) and (2) above, Government has implemented UGC 7th scheme in the State. Government has accorded sanction for granting placement of Teachers in Universities and Colleges in the State coming under 7th UGC Scheme from 18/07/2018 onwards, in accordance with the provisions in the UGC Regulations, 2018.

As per the provisions in UGC 2018 regulations, the claims for CAS (Assistant Professor Stage 2 and stage 3) has to be approved by the Screening cum Evaluation Committee constituted at the Colleges concerned.

As per the letters read (6) above, the Principals of Government Colleges have submitted the proposals for placement as Assistant Professor Stage 2 in respect of the teacher mentioned below, with recommendation of the Screening cum Evaluation Committee constituted at the Colleges.
