ORDER

As per the Government Orders read as 1st and 2nd above, Government has implemented UGC 7th scheme in the State. As per the Government orders read as 4th above, Government has accorded sanction for granting Placement of teachers in Universities and Colleges in the State coming under 7th UGC scheme from 18.7.2018 onwards, in accordance with the provisions in the UGC Regulation 2018.

As per the circular read as 7th above, the Principals of Government Colleges have submitted the proposals for placement to this office and placements were granted to eligible teachers.

Now as per 3rd Amendment the 7th UGC Regulation has been amended as “Wherever the requirement of the Orientation Course (OC)/Refresher Course (RC) has remained incomplete, the promotions would not be held up, but these requirements should be fulfilled by 31st December 2023 or as notified by the Commission from time to time”. As per the letter read as 9th above, Government also authorised the Director of Collegiate Education to comply the amendment. So placement proposals were submitted by teachers to prepone the placement date irrespective of course completion date based on 3rd amendment.

In the circumstances stated above, based on the recommendations of the College level Screening cum Evaluation Committee, the following faculties are given Placement on revised date, subject to the conditions, as Assistant Professor Academic level 11 (Stage 2) with rationalized Entry Pay Rs68,900/- from the date mentioned against each, under the 7th UGC Scheme vide G.O(P)No.18/2019/H.Edn.dated 29.06.2019.
