#### ORDER

As per the Government Orders read as 1 st and 2<sup>nd</sup> above, Government has implemented UGC 7<sup>th</sup> scheme in the State. As per Government orders read as 4<sup>th</sup> above, Government has accorded sanction for granting Placement of teachers in Universities and Colleges in the State coming under 7<sup>th</sup> UGC scheme from 18.7.2018 onwards, in accordance with the provisions in the UGC Regulations 2018.

As per the circular read as 7<sup>th</sup> above, the Principals of Government Colleges

have submitted the proposals for placement to this office and placements were granted to eligible teachers. Now, 7<sup>th</sup> UGC Regulation 3rd Amendment says that, "Wherever the requirement of the Orientation Course (OC)/Refresher Course (RC) has remained incomplete, the promotions would not be held up, but these requirements should be fulfilled by 31<sup>st</sup> December 2023 or as notified by the Commission from time to time". As per the letter read as 8<sup>th</sup> above, Government also authorized the Director of Collegiate Education to comply. So placement proposals were submitted by teachers to prepone the placement date irrespective of course completion date based on 3<sup>rd</sup> amendment.

In the circumstances stated above, based on the recommendations of the College level Screening cum Evaluation Committee, the following faculties are given Placement on revised date, subject to the conditions, as Assistant Professor Academic level 11 (stage 2) with rationalized Entry Pay Rs.68,900/- from the date mentioned against each, under the 7th UGC Scheme vide G.O(P) No.18/2019/H.Edn. dated 29/06/2019.
