ORDER

As per Government Orders read as 1 st and 2nd above, Government has implemented UGC 7th scheme in the State. As per Government orders read as 4th above, Government has accorded sanction for granting Placement of teachers in Universities and Colleges in the State coming under 7th UGC scheme from 18.7.2018 onwards, in accordance with the provisions in the UGC Regulations 2018.

As per the circular read as 7 th above, the Principals of Government Colleges have submitted the proposals for placement to this office and placements

were granted to eligible teachers. Now as per the 3rd Amendment, the 7th UGC Regulation has been amended as, "Wherever the requirement of the Orientation Course (OC)/Refresher Course (RC) has remained incomplete, the promotions would not be held up, but these requirements should be fulfilled by 31st December 2023 or as notified by the Commission from time to time". As per the letter read as 11th above, Government also authorized the Director of Collegiate Education to comply the Judgement. So placement proposals were submitted by teachers to prepone the placement date irrespective of course completion date based on 3rd amendment.

As per the circular read as 7th above, the Principals of Government Colleges have submitted the proposals for placement as Associate Professor (Academic Level 13A) to this office. According to the provisions in UGC 2018 Regulation, the claims for CAS - Associate Professor (Academic Level 13A) have to be approved by the Selection Committee constituted by the Director of Collegiate Education.

As per the minutes of the Selection Committee Meeting read as 9th above, eligible candidates were given placement in the post of Associate Professor (Academic Level 13A). The Subject Experts had verified and scrutinized the proposal of various subjects. After that subject wise Selection Committees were held at University College, Thiruvananthapuram from 24.02.2025 to 12.02.2025.

In the circumstances stated above, the following faculties are given Placement on revised date, subject to the conditions, were awarded Associate Professor Placement (Academic Level 13A) in the scale of Pay of Rs. 131400-217100/-
