As per the Government Orders read (1) and (2) above, Government has implemented UGC 7th scheme in the State. Government has accorded sanction for granting placement of Teachers in Universities and Colleges in the State coming under 7th UGC Scheme from 18/07/2018 onward, in accordance with the provisions in the UGC Regulations, 2018.

As per the provisions in UGC 2018 regulations, the claims for Career Advancement Scheme(CAS) (Assistant Professor Stage 2 and stage 3) has to be approved by the Screening cum Evaluation Committee constituted at the Colleges concerned.

As per the letters read (6) above, the Principals of Government Colleges have submitted the proposals for placement as Assistant Professor Stage 2 in respect of the teacher mentioned below, with Minutes of the Screening Committee constituted at the Colleges.

In the circumstances, based on the recommendations of the College level Screening cum Evaluation Committee and the service details received from Accountant General office read (7), the following faculties are given

1. This Order is subject to service verification of the Accountant General Kerala concerned for issuing pay slips.
2. If any amount drawn by the incumbent by this order is found to be in excess due to mistake or any other reason, noticed later, he/she would be liable to refund the amount so received in lump sum unconditionally.
3. The incumbent should submit his/her option and declaration for the fixation of pay within three months of this Order first to the respective office and thereafter to the Accountant General concerned with CTC.
4. If any undisclosed LWA/Service Break in the placement proposal, noticed later (during service or post-retirement), this placement and further placements of the concerned incumbent/s shall be invalid. Such extra/undeserved financial benefits enjoyed along with the said placements should either be refunded or recovered along with penal

interest. Revised placement proposals should be submitted in such cases for its regularisation.
