ORDER

As per the Government Orders read as 1st and 2nd above, Government has implemented UGC 7th scheme in the State. As per the Government orders read as 4th above, Government has accorded sanction for granting Placement of teachers in Universities and Colleges in the State coming under 7th UGC scheme from 18.07.2018 onwards, in accordance

with the provisions in the UGC Regulation 2018.

As per the circular read as 7th above, the Principals of Government Colleges have submitted the proposals for placement to this office and placements were granted to eligible teachers.

Now as per 7th UGC Regulation 3rd Amendment, “Wherever the requirement of the Orientation Course (OC)/Refresher Course (RC) has remained incomplete, the promotions would not be held up, but these requirements should be fulfilled by 31st December 2023 or as notified by the Commission from time to time” So placement proposals were submitted by teachers to prepone the placement date irrespective of course completion date based on 3rd amendment.

As per the circular read as (9) the subject experts and selection committee was formed. The Subject Experts verified and scrutinised the proposal of various subjects. After that selection committee were held at Collegiate Education Department, Thiruvananthapuram on 13.01.2026

The placement granted as per this Order is subject to the following conditions.

1. This Order is subject to verification of the Accountant General Kerala concerned for issuing pay slips.
2. If any amount drawn by the incumbent by this Order is found to be in excess due to mistake or any other reason, noticed later, he/she would be liable to refund the amount so received in lump sum unconditionally.
3. The incumbent should submit his/her option and declaration for the fixation of pay within three months of this Order to the Accountant General concerned (with CTC).
4. If any undisclosed LWA/Service Break in the placement proposal, noticed later (during service or post retirement), this placement and further placements of the concerned incumbent/s shall be invalid. Such extra/undeserved financial benefits enjoyed along with the said placements should either be refunded or recovered along with penal interest. Revised placement proposals should be submitted in such cases for its regularisation.
